  - i) Jessica Castillo – OTA-006796 – Reinstatement  
Ms. Whiteford provided a summary of the matter. Ms. Paulson stated Ms. Castillo may have violated A.R.S. 32-3401.9(z) for failing to renew her license while continuing to practice. Dr. McCallister stated that a letter of concern would be consistent with the Board’s disciplinary matrix. Mr. Harris stated that a letter of concern would require that a complaint be opened. Dr. McCallister moved the Board open a complaint and issue a letter of concern for practicing two days with an expired license. Ms. Chiantella seconded the motion. The motion passed 4-0 by roll call vote.
  - ii) Natalie Garland – OTH-003739 – Disclosure  
Ms. Paulson summarized the matter and verified, with Board staff, that Ms. Garland completed all requirements of the interim consent agreement in a timely manner. Dr. McCallister stated he was open to offering Ms. Garland a consent agreement for probation with a requirement for community courses. Ms. Paulson moved the Board enter executive session for legal advice. Dr. McCallister seconded the motion. The motion passed 4-0 by roll call vote. The Board entered executive session at 1:59 p.m. and returned to regular session at 2:10 p.m. Following deliberation, Ms. Paulson moved the Board approve Ms. Garland’s renewal upon execution of a consent agreement that includes a two-year probation with six months stayed upon completion of weekly individual counseling sessions with an Arizona-licensed counselor selected by Ms. Garland and submitted to Board staff for approval and a requirement that Ms. Garland submit proof of completion of court mandated alcohol-related courses. Mr. Harris suggested the Board may want to change the terms to a two-year probation with an option to modify after six months. Mr. Daly suggested that the frequency should be up to the counselor with a minimum of one session per week unless the counselor recommends a different frequency. Ms. Paulson accepted the friendly amendments and added that proof of attendance of must be submitted quarterly. Dr. McCallister seconded the motion. The motion passed 4-0 by roll call vote.


