- a) Executive Director's Report Verbal Report and Discussion No Action Required
 - i) Licensing Waivers Pursuant to Administrative Order 2020-01 and Executive Order 2020-17 Ms. Whiteford described the types of waivers being offered to applicants pursuant to the two orders.

5) REVIEW, CONSIDERATION, AND POSSIBLE ACTION ON APPLICATIONS FOR LICENSURE

- a) Renewal/Reinstatement Applications Board Review
 - i) Jessica Miltner, OTH-003860 Reinstatement
 - Ms. Miltner joined the meeting with a better connection. Dr. McCallister asked Ms. Whiteford what date the executive order was issued. Ms. Whiteford asked how that affects this matter. Dr. McCallister stated that exceptions have been made for others who were not able to renew. Ms. Marbs stated to Ms. Miltner that she was curious as to why she had practiced for so many months with an expired license. Ms. Miltner stated that it was just a mistake and that she had been practicing for 14 years. Ms. Marbs asked if there were extenuating circumstances. Ms. Miltner said there were not. Ms. Paulson asked Ms. Miltner if her employer knew. Ms. Miltner said her employer knew and they notified her but she didn't renew. She further stated that the email she received said the her license was going to expire, not that it had expired. The Board determined that Ms. Miltner practiced approximately 60

days with an expired license. Ms. Marbs asked Ms. Whiteford to look at the matrix for practicing with an expired license. Ms. Whiteford reported that the matrix listed a one-year probation and three hours of continuing education in ethics for a person who practiced with an expired license approximately 60 days. Dr. McCallister moved the Board reinstate Ms. Miltner's license. Ms. Paulson seconded the motion. The motion passed by roll call vote with all members voting aye. Dr. McCallister moved the Board offer Ms. Miltner a consent agreement to include a one-year probation and three hours of continuing education in ethics within six months of execution of the consent agreement. Dr. McCallister clarified that the three hours of continuing education must be in addition to the 20 hours required for license renewal. Dr. Hosenfeld seconded the motion. The motion passed by roll call vote with all members voting aye.

Dr. McCallister requested that the status of the open Board member position be added to the May agenda.
