9) REVIEW, CONSIDERATION, AND POSSIBLE ACTION – BOARD BUSINESS AND REPORTS

a) Financial Report

i)

Ms. Whiteford stated that the agency is projected to have a positive cash balance at the end of fiscal year 2019. She further stated that she is not confident in the projected cash balance and will work with ADOA Central Service Bureau to confirm the forecast.

- b) Administrative Project Status Report
 - Policies and Procedures Ms. Whiteford informed the Board that she will present at least three new policies and procedures for approval at the May Board meeting.

- ii) Application Automation (eLicensing) Ms. Whiteford stated that the eLicensing system is currently stable.
- Rule Updates
 Ms. Whiteford stated that bills currently at the Legislature would affect the rule modifications the Board is pursuing and advised the Board that it may be beneficial to wait until the session is over before continuing to pursue rule changes. The Board agreed.
- c) 2019 Bills to Watch
 - i) HB 2118 unauthorized practice; health professions
 Ms. Whiteford stated that HB 2118 allows Boards to regulate the unauthorized practice of the health profession they regulate. She also stated the bill has progressed through the legislature and will likely be transmitted to the Governor for signature.
 - ii) HB 2131 state agencies; citizen portal; access
 Ms. Whiteford informed the Board that HB 2131 requires that state agencies allow licensees to access the information collected by the agency and correct any errors.
 - iii) HB 2182 permit; license; denials; agency hearing
 Ms. Whiteford stated that HB 2182 requires agencies to specify the criteria for license approval in clear and unambiguous language. Ms. Whiteford further stated she believe the next step for the bill is the third read.
 - iv) HB 2463 occupational regulations; licenses; communications; notice Ms. Whiteford informed the Board that HB 2463 was signed by the Governor and requires state agencies post a notice on its website and an any licensing documents that states the applicant has a right to challenge the occupational regulation.
 - v) HB 2501 electronic records; state library Ms. Whiteford stated that HB 2501 requires the State Library to establish a fund to preserve and maintain electronic records.
 - vi) HB 2569 occupational licensing; reciprocity
 Ms. Whiteford informed the Board that HB 2569 was signed by the Governor and requires agencies to issue licenses to persons who hold a license in another state and establish residence in Arizona.
 - vii) HB 2660 occupational regulation; prior conviction; applicability
 Ms. Whiteford stated that HB 2660 prohibits an agency from determining that a person's conviction of specified offenses from over seven years ago disqualifies the person from obtaining a license. Ms. Whiteford further stated that the proposed law allows the agency to disqualify a person for a dangerous offense, serious offense, dangerous crime against children or sexual offense and the conviction has not been set aside
 - viii) HB 2724 GRRC; petition to request review Ms. Whiteford stated that HB 2727 was held.
 - ix) SB 1062 public disclosure; health professionals; address Ms. Whiteford informed the Board that SB 1062 will likely pass and requires Boards to have an address of record for each license that may be publicly disclosed and to have the telephone or e-mail address of each licensee who is required to maintain patient medical records. Ms. Whiteford further stated that this bill allows the licensee to opt out of the disclosure.
 - x) SB 1086 health professions; temporary licensure Ms. Whiteford stated that she believes SB 1086 will likely pass and allows the Board to grant authority for their executive director to issue and approve licenses, certifications, registrations, preceptorships, reinstatement or waivers to an applicant or licensee that meets certain requirements. Ms. Whiteford further stated that the bill also allows the Board to issue temporary licenses.
