1) CALL TO ORDER

Ms. Paulson called the meeting to order at 1:32 p.m.

2) ROLL CALL

The following members were present: Barbara Paulson, Charlene Marbs (by Webex), Christopher Daly, and Quenton McCallister (by Webex).

4) REVIEW AND CONSIDER FUTURE BOARD MEETING SCHEDULE

5) REVIEW, CONSIDERATION, AND POSSIBLE ACTION REGARDING APPROVAL OF THE MEETING MINUTES

- a) Executive Session Meeting Minutes of February 12, 2021, 1:59 p.m.
Ms. Paulson moved the Board approve the executive session meeting minutes of February 12, 2021. Dr. McCallister seconded the motion. The motion passed 3-1 by roll call vote, with Ms. Marbs abstaining because she was not present for the meeting.

- b) Regular Session Meeting Minutes of June 11, 2021
Due to Ms. Chiantella's resignation from the Board, the Board will not meet the quorum requirement for this agenda item. An audio recording of the meeting is available on ot.az.gov.
- c) Regular Session Meeting Minutes of July 9, 2021
Ms. Paulson moved the Board approve the regular session meeting minutes of July 9, 2021. Ms. Marbs seconded the motion. The motion passed 4-0 by roll call vote.

6) REVIEW, CONSIDERATION, AND POSSIBLE ACTION – COMPLAINTS, INVESTIGATIONS AND COMPLIANCE

- a) Initial Review of Complaints
 - i) Lisa Rea, OTH-006853, Complaint 2020-OT-0001
Ms. Rea was present via Webex and made a brief statement. Ms. Whiteford stated that the complainant's meeting notice was returned as undeliverable. When asked if the laptop was operational when returned, Ms. Rea stated that it was operational and the patient files were located on the laptop's hard drive. The Board took a recess from 1:57 p.m. to 2:12 p.m. to address audio technical difficulties. Upon return to open session, Ms. Paulson moved the Board dismiss the complaint. Mr. Daly seconded the motion. The motion passed 4-0 by roll call vote.

 - c) None

7) REVIEW, CONSIDERATION, AND POSSIBLE ACTION ON APPLICATIONS FOR LICENSURE

- a) Initial Applications – Board Review
 - i) Warren Joiner – Disclosure
Mr. Joiner was not able to hear the Board members present in the Boardroom. The item was tabled until the audio problem was corrected.
 - ii) Austin Mulder – Disclosure
Mr. Mulder appeared in-person and was available for questions. Ms. Paulson summarized Mr. Mulder's disclosure. Ms. Marbs moved the Board approve Mr. Mulder's application. Mr. Daly seconded the motion. The motion passed 4-0 by roll call vote.
 - iii) Patrick Romero – Disclosure
Ms. Paulson summarized Mr. Romero's disclosure that he practiced 147 days after his license expired on October 16, 2020. After referring to the Board's disciplinary action matrix, Dr. McCallister moved the Board offer Mr. Romero a consent agreement for one year of probation and six hours of continuing education. Mr. Larson stated the Board must adopt findings of fact and conclusions of law prior to determining disciplinary action(s). Dr. McCallister rescinded his motion. Dr. McCallister moved the Board adopt the findings of fact and conclusions of law based on violation of A.R.S. § 32-3401.10(z) for failing to renew a license while continuing to practice occupational therapy, and offer Mr. Romero a consent agreement for one year of probation to include a requirement for six hours of continuing education in medical ethics in addition to the continue education hours required for renewal of his license. Ms. Paulson seconded the motion. The motion passed 4-0 by roll call vote. Ms. Marbs moved the Board approve Mr. Romero's license upon acceptance of the consent agreement. Mr. Daly seconded the motion. The motion passed 4-0 by roll call vote.
- b) Limited License Applications – Board Review
 - i) None
- c) Renewal/Reinstatement Applications – Board Review
 - i) Brandon Jones, OTH-006168 – Disclosure
Ms. Paulson summarized the disclosure provided by Mr. Jones. Mr. Jones was present via Webex and available for questions. Ms. Paulson moved the Board go into executive session for legal advice. Mr. Daly seconded the motion. The motion passed 3-1 by roll call vote, with Ms. Marbs leaving the meeting due to a conflicting appointment. The Board entered

executive session at 3:03 p.m. and returned to regular session at 3:43 p.m. Upon return to regular session, Ms. Paulson moved the Board open a complaint against Mr. Jones and grant renewal of his license upon acceptance of a consent agreement. The consent agreement should be based on findings of fact and conclusions of law for violations of A.R.S. §§ 32-3401(10)(f), 32-3401(10)(o), and 32-3208. Dr. McCallister seconded the motion. The motion passed 3-1, with Ms. Marbs being absent. The Board then discussed the potential requirements of the consent agreement. Dr. McCallister stated he would like to see line-of-sight supervision, which would eliminate the ability of Mr. Jones to practice home health. Mr. Jones asked if he would have to have another occupational therapist present while he treated. Ms. Paulson reminded Mr. Jones that the Board has an obligation to the public to protect their safety and well-being. Ms. Paulson moved the Board offer Mr. Jones a consent agreement conditionally granting a restricted license until he submits proof he has completed all court-ordered requirements and he completes a fitness to practice evaluation, at his own expense, performed by a practitioner approved by Board staff. Ms. Paulson added that Mr. Jones' license would be denied if he did not accept the consent agreement within 30 days. Dr. McCallister seconded the motion. The motion passed 3-1 by roll call vote with Ms. Marbs being absent. Ms. Whiteford asked Mr. Jones if he would prefer to have the consent agreement sent via U.S. Mail or through email. Mr. Jones stated he would prefer to receive the agreement through email.
