9) REVIEW, CONSIDERATION, AND POSSIBLE ACTION – BOARD BUSINESS AND REPORTS

- a) Occupational Therapy Licensure Compact
 - Ms. Whiteford stated she attended a meeting regarding the proposed occupational therapy licensure compact and expressed concerns that it could be difficult to find a sponsor for a bill with upcoming changes to the legislature. She also stated that system changes would require additional funds in the agency's budget.
- b) Fiscal Year 2022 Budget Request
 Ms. Whiteford stated there will be significant changes to the fiscal year 2022 budget request
 because ASET will not be charging the increased support fees. Forecast revenue for fiscal year

because ASET will not be charging the increased support fees. Forecast revenue for fiscal year 2021 decreased because of the reduction of licensees due to COVID and the fee waivers issued due to COVID.

- b) Renewal/Reinstatement Applications Board Review
 - i) Natalie Garland OTH-003739
 - Ms. Marbs asked Ms. Garland why her classes of August 22 and 23 were rescheduled. Ms. Garland stated that they were rescheduled due to childcare issues. Dr. McCallister asked Ms. Garland what the meeting were like. Ms. Garland stated that each meeting is a different topic,

with the last meeting being about conflict resolution. Dr. McCallister stated the reason this is being looked at so closely is because she had two DUI convictions within roughly a year and did not disclose them until she submitted her renewal. He added that he felt it would be appropriate to have an independent evaluation of Ms. Garland's alcohol use. Ms. Paulson agreed. Ms. Garland stated she is willing to undergo an evaluation. Ms. Paulson stated that it would provide the Board with more information and a firmer foundation to base the decision on Ms. Garland's ability to practice. Dr. McCallister moved the Board offer and interim consent agreement that would require Ms. Garland to have an independent alcohol use evaluation approved by Board staff and be at Ms. Garland's expense. Ms. Paulson added that a licensed provider must do the evaluation. Within 30 days and evaluation done within 60 days. Ms. Garland asked to confirm that she is to find the provider and submit the provider's information to Ms. Whiteford. Ms. Marbs seconded the motion. The motion passed 3-0 by roll call vote. Dr. McCallister moved the Board continue the renewal approval matter until the results of the evaluation are received. Ms. Marbs seconded the motion. The motion passed 3-0 by roll call vote.
