**1) CALL TO ORDER**

Dr. McCallister called the meeting to order at 1:30 p.m.

**5) REVIEW, CONSIDERATION, AND POSSIBLE ACTION REGARDING APPROVAL OF THE MEETING MINUTES**

- a) Regular Session Meeting Minutes of November 13, 2020

Ms. Whiteford stated the November minutes were not yet available for review. The matter was tabled to the next meeting.

**6) REVIEW, CONSIDERATION, AND POSSIBLE ACTION – COMPLAINTS, INVESTIGATIONS AND COMPLIANCE**

- a) Initial Review of Complaints
  - i) James Boyd, OTH-003394 – 2019-OT-0008

Dr. McCallister stated the complaint alleges Mr. Boyd.....Mr. Boyd was present via Webex and answer Board member questions. Following deliberation, Dr. McCallister moved the Board issue a non-disciplinary consent agreement and letter of concern for errant billing, with

a requirement of three hours of continuing education in ethics and billing due within six months of execution of the consent agreement. Ms. Marbs seconded the motion. The motion passed 3-0 by roll call vote.

ii) Victor Rivera, OTA-007047 – 2019-OT-0018

Dr. McCallister moved the Board go into executive session for legal advice. Ms. Paulson seconded the motion. The motion passed 3-0 by roll call vote. The Board entered executive session at 1:55 p.m. and returned to regular session at 2:05 p.m. Dr. McCallister asked if Mr. Rivera was convicted and in prison. Ms. Whiteford stated that Mr. Rivera was convicted and sentenced to 15 years with the Department of Corrections and lifetime probation. Ms. Whiteford reviewed the investigative report which found that Mr. Rivera was found guilty of molestation of a child (class 2 felony), attempted sexual contact with a minor (class 3 felony), and dangerous crimes against children in the second degree. Ms. Whiteford further stated that Ms. Khan drafted a Consent Agreement and Order for Revocation, which was mailed by certified and regular mail to Mr. Rivera. The Board may choose to accept the consent agreement in advance of receiving the signed document from Mr. Rivera. Dr. McCallister moved the Board accept the signed consent agreement and to move the matter to formal hearing if Mr. Rivera does not accept the consent agreement. Ms. Paulson seconded the motion. The motion passed 3-0 by roll call vote.
