Ms. Marbs provided a summary of the complaint that was originally reviewed at the October 15, 2023 Board meeting. Ms. Marbs made a motion to move to Executive Session for legal advice. Ms. Donald seconded the motion. The motion passed by 3-0 roll vote. Executive Session started at 1:53 p.m. Executive Session ended at 2:21 p.m. Ms. Marbs made a motion to offer a consent agreement for approval and issuance of licensure to Ms. Gonzales with the required completion of five (5) years probation and a \$20,000 civil penalty fee payable over a period of five (5) years with \$4,000 due at the end of every year. The motion did not receive a second and the motion failed to pass. Ms. Marbs made a motion to offer a consent agreement for approval and issuance of licensure to Ms. Gonzales with the required completion of five (5) years probation and a \$10,000 civil penalty fee payable over a period of five (5) years with \$2,000 due at the end of every year. Mr. Williams seconded the motion. The motion passed by 3-0 roll vote. Following the vote, Ms. Donald expressed that she did not intend to vote in the affirmative, therefore, indicating nay. The motion passed by 2-1 roll vote. Ms. Marbs made a motion for the requirement of Ms. Gonzales to sign the consent agreement within 30 days of issuance with denial of her license if not signed. Mr. Williams seconded the motion. The motion passed by 3-0 roll vote.
